## Re: Freedom of Information Request FOI-000007-2022 Request Granted

#### Dear

I refer to your request, dated 3<sup>rd</sup> January, 2022 and received on 4<sup>th</sup> January, 2022 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

FOI Request under 2014 Act

The number of Gardaí attached to the Naas Road Policing Unit as of 1 January 2022.

Broken down by Garda, Sergeant and any higher ranks if applicable.

I wish to inform you that I have decided to grant your request on 13th January, 2022.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant section of An Garda Síochána where a search was conducted in respect of same and a number of records were identified.

I have been advised that the Naas Road comes under the Dublin Metropolitan Region of An Garda Síochána. As at the 31/12/2021 the number of Gardaí attached to the DMR Roads

Policing Unit is as follows: 1 Chief Superintendent, 2 Superintendents, 3 Inspectors, 10 Sergeants and 90 Gardaí. DMR South Traffic Corps comprises of 1 Inspector, 1 Sergeant and 9 Gardaí.
